

**ADVERTISEMENT FOR BIDS**  
**ROCK-KOSHKONONG LAKE DISTRICT**  
**DREDGING AND SHORELINE RESTORATION PROJECT**  
Town of Sumner- Jefferson County, Wisconsin

The Rock-Koshkonong Lake District (DISTRICT) seeks a qualified contractor to undertake a dredging and shoreland restoration project on portions of Lake Koshkonong located in the Town of Sumner, Jefferson County, Wisconsin in early 2013 as described below:

**PROJECT DESCRIPTION:** The project involves dredging silty sand lake sediment in a drawn down condition by mechanical excavation located in front of the public boat landing at the end of North Shore Road; the construction of a containment berm located in front of a wetland shoreline on Lake Koshkonong located approximately 3,500 feet southeast of the boat landing; and the transportation and placement of the dredged materials behind the containment berm. Dredging will be to a 0-2 foot depth from approximately 2.3 acres and will result in approximately 3,440 cubic yards of material. The containment berm will be approximately 550 feet in length and constructed of rock (breaker run faced with riprap).

**BIDDING DOCUMENTS:** BIDDING DOCUMENTS may be examined or obtained on December 13, 2012 at the office of Montgomery Associates: Resource Solutions, LLC at 119 S. Main St., Cottage Grove, WI 53527 upon receipt of a non-refundable fee of \$55 for the Project Manual and a 11" x 17" set of plans. Free electronic copies of the BIDDING DOCUMENT will also be made available by calling Montgomery Associates: Resource Solutions, at 608-839-4422.

**PREVAILING WAGE:** Pursuant to Wis. Stat. § 66.0903, Wisconsin Statutes, the minimum wages to be paid on the project shall be in accordance with the wage rate scale established by Wage Rate Determination #201202580.

**PRE-BID CONFERENCE:** A pre-bid conference will be held at 1 p.m., January 3, 2013 at the Lake Koshkonong North Shore Drive Boat Launch. Representatives of the DISTRICT and ENGINEER will be present to discuss the project. Bidders are REQUIRED to attend and participate in the conference in order to bid on the project.

**TIME AND PLACE OF BID OPENINGS:** Sealed proposals for the project will be received at the office of Montgomery Associates: Resource Solutions, until 10 a.m. on January 9, 2012; and at that time will be publicly opened and read aloud. All bidders must bid in accordance with and shall bid upon the forms in the BIDDING DOCUMENTS. The contract is expected to be awarded at a January 10, 2013 Board Meeting of the Rock-Koshkonong Lake District.

**BID REJECTION:** The DISTRICT reserves the right to reject any and all bids, waive any informalities in bidding, or accept the bid or bids which best serve the interest of the District.
