- 2. Confirmation of meeting notice and approval of agenda:
- 3. Approval of July 27, 2007, minutes (post annual meeting): A motion was made to accept the July 27, 2007 minutes as presented by Jeff Folk, seconded by Ray Lunder. There being no questions or discussion, on a voice vote, the motion adopted.

Old Business: Update on Rock County Circuit Court Proceeding: A report was given by Mary Beth Perenteau of Wheeler and VanSickle, regarding the issues pending of the court proceeding. She also answered questions from the audience regarding the next steps that must be taken should Judge Dillon should rule against us. Mary Beth also stated previous cases and the outcomes.

The hearing that was scheduled for Friday, December 14, has been postponed because Judge Dillon has a trial starting and needed additional time to prepare for it. Our hearing will be postponed until after the holidays.

6. New Business: Certified Audit Options/Costs: Chairman Christianson stated there had been questions at the annual meeting whether our audit was actually a certified audit. He has made several inquiries at various auditing companies. He received quotes of \$6.000 - \$8,000. A question was asked if a certified audit was actually necessary or mandatory. He will continue his research of certified audits, and at the next meeting the Board can decide if this will be necessary and at what cost.
